The City of Grants, NM will receive sealed bid proposals on forms prepared by Wilson and Company, Inc., E&A via virtual bid opening. Bids will be accepted until **10:00 a.m.** (local time) on **October 20th, 2021**. Bids received after this time will not be received.

The project consists of installing new gravity flow storm drain within the right-of-way, excavating a new pond with concrete pump station, and installation of a stormwater forcemain pipe to the outfall in Rio San Jose.

Bidder Requirements:
