Competitive sealed bids will be received by the City of Anthony, NM, for full depth roadway reconstruction, pedestrian access enhancements and drainage improvement along Acosta Road from NM-460 to 4th Street in Anthony New Mexico located at 32.010341, Latitude, - 466.604187 Longitude. The project length is approximately 1,015 linear feet. Improvements consist of the removal to the existing dilapidated roadway section, installation of new base course, hot mix asphalt curb and gutter, concrete sidewalk on both sides of the road, colored and Pattern concrete, erosion control rock, permanent signing and striping and drainage drop inlet structure for IFB NO. 2022-002, Project No.: CDBG 20-C-NR-I-01-G-16, Project Name, :Acosta Road Roadway and Drainage Improvements, at the City of Anthony NM Municipal Building, 820 Highway 478, Anthony, NM 88021 until December 16th, 2022, at 10:00 a.m. at which time bids will be opened and publicly read aloud.
