Bids received after this time will not be accepted.

The Project consists of the construction of approximately 1,152 linear feet of 6-inch PVC waterline; 4-inch PVC waterline; valve vault and appurtenances; and all other incidental and appurtenant work required to complete the improvements as shown and specified. Bids shall be on a unit price basis.
