Sealed Bids for the construction of the Waterline Transmission Project will be received by City of Garden City (OWNER) at the office of 301 N. 8th Street, Garden City, KS 67846, until 2:00 PM local time on December 21, 2021, at which time the Bids received will be publicly opened and read. Bids received after this time will not be accepted.

The Project is generally described as a water system improvement project as follows:

Transmission Waterline (Contract A): Work includes furnishing all the labor, materials, and equipment for the utility improvements. The improvements include approximately 11,655 linear feet of 16-inch water piping, 2,292 linear feet of 16-inch Directional Drill water piping, 805 linear feet of auger & jack steel encasement piping, 16 gate valves, 3 tapping sleeve & valves, 5 fire hydrants, site clearing and restoration, removal and replacement of surfacing, construction staking, mobilization, erosion control, traffic control, grass seeding, and all other incidental and appurtenant work required to complete the improvements as shown and specified.
