The Pueblo of Jemez (Owner) is requesting Bids for the construction of the following Project:

NM 4 Multi-use Pedestrian Trail

Bids for the construction of the Project will be received at the **Pueblo of Jemez Welcome Center, 7413 NM-4, Jemez Pueblo, NM 87024**, until **Monday, November 21, 2022, at 11:30 am** local time. At that time the Bids received will be publicly/virtually opened and read, a separate virtual meeting invite will be provided.

The project consists of constructing a 10-ft wide multi-use pedestrian trail for 1.78 miles along NM 4 through the Pueblo of Jemez. The project consists of subgrade prep, base course, HMA, curb and gutter, drainage structure improvements, grading, lighting, signing/stripping, and landscaping. The trail will include two mid-block crossings and two pedestrian bridges.
